

ABOUT THE EDITORS AND CONTRIBUTORS

Donald Allensworth-Davies, PhD, is an assistant professor with the School of Health Sciences at Cleveland State University, where he is also the coordinator for the Consortium of Eastern Ohio Master of Public Health Program. He served as co-investigator for one of the first national surveys in the United States of gay prostate cancer survivors funded by the National Cancer Institute, and he continues to focus his research efforts on GBT prostate cancer survivorship as well as health disparities among LGBT elders.

Jonathan Bergman, MD, MPH, is assistant professor of urology and family medicine at UCLA, and at Olive View–UCLA Medical Center and the Veterans Administration Greater Los Angeles. His research and clinical focus includes health services research, population health, and end-of-life care.

Thomas O. Blank, PhD, is professor emeritus in the Department of Human Development and Family Studies at the University of Connecticut. His article in the *Journal of Clinical Oncology* in 2005 was the first to identify the specific needs and issues of gay men with prostate cancer. He and his colleagues Marysol Asencio and Lara Descartes have contributed a number of chapters and articles to the literature on gay men and prostate cancer and, more generally, LGBTQ communities and cancer.

Perry Brass's nineteen published books include the best-selling self-help books *How to Survive Your Own Gay Life* (1999) and *The Manly Art of Seduction* (2010), the futurist novel *Carnal Sacraments* (2007), and the coming-of-age novel *King of Angels* (2014), a finalist for a Ferro-Grumley Award from New York's Publishing Triangle, set in Kennedy-era Savannah, Georgia. In 1969 he coedited *Come Out!*, the world's first gay liberation newspaper, published by the Gay Liberation Front. In 1972 he cofounded with two friends the Gay Men's Health Project Clinic, the first clinic specifically for gay men on the East Coast, still operating as the Callen-Lorde Community Health Center. Brass's work deals with issues of sexual freedom, personal authenticity, and liberation politics that have emerged from his continuing involvement—ever since the Stonewall Rebellion—with the movement for what is now called LGBT rights..

Benjamin D. Capistrant, ScD, is an assistant professor and social epidemiologist in the Division of Epidemiology and Community Health at the University of Minnesota School of Public Health, Minneapolis. He specializes in aging research, including examining the social support and caregiving needs of GBM prostate cancer survivors, their spouses, and support networks.

Lynae Darbes, PhD, is a psychologist and behavioral scientist whose primary focus is the influence that partners and relationship dynamics have on health behavior. Her career has also focused on investigating the relationship context of sexual minorities,

especially same-sex male couples. She has been principal investigator on several NIMH-funded grants to develop and test interventions focused on couples, including same-sex male couples.

Brian de Vries, PhD, is a professor of gerontology at San Francisco State University; he received his doctorate in life-span developmental psychology from the University of British Columbia in 1988. Dr. de Vries is a fellow of the Gerontological Society of America and past board member of the American Society on Aging. He has edited five books, authored or coauthored over 100 journal articles and book chapters, and given more than 150 presentations to local, national, and international professional audiences on the social and psychological well-being of midlife and older LGBT persons, among other topics.

Gary W. Dowsett, PhD, is a professor, deputy director, and chair at the Australian Research Centre in Sex, Health, and Society at La Trobe University, Melbourne. A sociologist, he has specialized in HIV/AIDS research, both internationally and in Australia's gay communities. He has also worked in sexuality and masculinity studies and men's health. He is a fellow of the Academy of the Social Sciences in Australia.

Murray Drummond, PhD, is a professor in sport, health, and physical activity and the director of the SHAPE Research Centre at Flinders University, Adelaide, Australia. His research interests are in qualitative health research, with a particular focus on men and masculinities within the context of sport, health, and body image.

Duane Duncan, PhD, is a lecturer at the University of New England, New South Wales, Australia, and an adjunct research fellow at the Australian Research Centre in Sex, Health, and Society at La Trobe University, Melbourne. His work as a sociologist explores broad shifts in the performance of masculine identities in relation to consumer culture, neoliberal governmentality, and wider transformations in gender relations characterizing late modernity.

Daniel R. du Plooy, MPhil, is a PhD candidate and research officer at the Australian Research Centre in Sex, Health, and Society at La Trobe University, Melbourne. His current research is on migrant well-being in Australia.

Shaun Filiault, PhD, holds an LLM in U.S. law and is currently pursuing a doctorate in law at the University of New Hampshire, having previously been awarded a PhD in health sciences. He is a professor of psychology at River Valley Community College in New Hampshire and a judicial law clerk in the U.S. District Court for the District of Massachusetts. He previously held a position as a lecturer in health promotion at Flinders University, Adelaide, Australia.

Clement K. Gwede, PhD, MPH, RN, FAAN, is a senior member and professor of health outcomes and behavior and population sciences at Moffitt Cancer Center and the University of South Florida's Department of Oncologic Sciences in the Morsani College of Medicine, Tampa. His research addresses health disparities and informed and shared decision making across the continuum of cancer control, including the role of patient preferences, toxicities, and quality of life in treatment decisions among patients with newly diagnosed localized prostate cancer.

Crystal Hare, BSc, is completing a master's degree in clinical psychology at Ryerson University, Toronto, Canada. Her primary research focus is psychosocial oncology, including changes in sleep patterns and fatigue levels associated with cancer diagnosis and treatment.

Tae L. Hart, PhD, CPsych, is professor of psychology at Ryerson University, Toronto, Canada. Tae's research centers on psychological factors associated with adjustment to illness in chronically ill individuals, primarily quality of life, psychological distress, and symptom burden in patients who have been diagnosed with cancer, multiple sclerosis, or gastrointestinal disorders.

Ross Henderson, Grad Dip Couns, is currently completing his master's in Gestalt psychotherapy. He is a counselor and psychotherapist in private practice in Sydney, Australia. He has over 20 years' experience in adult education and has delivered training as both lecturer and tutor to undergraduate and postgraduate students in counseling psychology. He has worked for a variety of corporate and nongovernmental organizations in both managerial and counseling capacities over the last 30 years.

Michael A. Hoyt, PhD, is an associate professor in health psychology and clinical science at Hunter College of the City University of New York. His work focuses on biobehavioral processes related to psychological adjustment and coping with chronic illness, emotion regulation, cancer survivorship, gender, and evidence-based intervention.

Shanda L. Hunt, MPH, is an assistant librarian and data-curation specialist at the School of Public Health at the University of Minnesota, Minneapolis. She conducted the structured literature search cited in chapter 1.

Charles Kamen, PhD, MPH, is a clinical psychologist with a strong background and training in behavioral medicine, health disparities, and dyadic interventions. His program of research focuses on (1) cancer-related health disparities affecting sexual- and gender-minority cancer survivors, and (2) behavioral interventions to address these disparities. He is currently principal investigator on an NCI-funded grant focused on sexual- and gender-minority cancer survivors and their caregivers.

Andrew Kellett, BPsych, is a researcher and doctoral candidate in the Translational Health Research Institute, School of Medicine, Western Sydney University. His focus is on mixed-methods research into health inequalities and marginalized groups.

Nidhi Kohli, PhD, is an associate professor in the Department of Educational Psychology, College of Education and Human Development, at the University of Minnesota, Minneapolis. Her research focuses on the development and improvement of statistical methods for analyzing longitudinal data, and she is the research methodologist and statistician on the Restore study.

Badrinath R. Konety, MD, MBA, is a professor and chair of the Department of Urology and director of the Institute for Prostate and Urologic Cancers at the University of Minnesota Medical School, Minneapolis. A board-certified urologist, fellow of the American Cancer Society and the American Urological Association, and research expert in biomedical aspects of prostate cancer treatment, he has been listed as a Best Doctor in America since 2009.

David M. Latini, PhD, MSW, is an associate professor of urology and psychiatry at Baylor College of Medicine, Houston, where he teaches medical students human sexuality and LGBT health, and a private-practice psychologist. His research work focuses on genitourinary cancer survivorship, symptom management, and health literacy. With Tae Hart, he led the first study of the effect of prostate cancer on gay men in the United States and Canada.

Mark S. Litwin, MD, MPH, is professor of urology, public health, and nursing at UCLA, where he practices urologic oncology, teaches, and conducts research in translational population science, including outcomes, quality of life, costs, and quality of care. He directs a large state-funded program that provides free care to low-income, uninsured men with prostate cancer in California.

Emilia Lombardi, PhD, is an assistant professor in Baldwin Wallace University's Department of Public Health, Berea, Ohio. She has a PhD in sociology from the University of Akron and has been examining health disparities among lesbian, gay, bisexual, and transgender populations since the mid-1990s.

Brett M. Millar, PhD, is a postdoctoral researcher in Health Psychology and Clinical Science Program at the City University of New York and Hunter College's Center for HIV Educational Studies & Training. His work focuses on the health of gay and bisexual men, including understanding self-regulation in health behavior and decision making.

Darryl Mitteldorf, LCSW, is an oncology social worker. He is the founder of two U.S.-based national cancer survivor support and advocacy nonprofit organizations, Malecare and the National LGBT Cancer Project.

Gerald Perlman, PhD, is a clinical psychologist, certified psychoanalyst, and certified bioenergetic therapist in private practice in New York City. He is a former supervisor and director of psychology internship training at Manhattan Psychiatric Center. Currently he is on the faculty and organizing committee of the New York Society of Bioenergetic Analysis.

Janette Perz, PhD, is a professor of psychology and director of the Translational Health Research Institute at Western Sydney University, Australia. Her research is in the area of gendered sexual and reproductive health. She has been co-investigator with Jane Ussher in a significant research program in psycho-oncology, including cancer carers, sexual experiences and interventions for couples facing cancer, and changes to fertility across a range of cancer types.

Garrett P. Prestage, PhD, is an associate professor at the Kirby Institute, University of New South Wales, Sydney, where he has worked since 1992. He has been active in gay community life in Australia since the mid-1970s. He pioneered HIV behavioral surveillance work and major cohort studies among Australian gay and bisexual men.

Gwendolyn P. Quinn, PhD, the Livia Wan Endowed Chair, vice chair of research, and professor in the Departments of Obstetrics and Gynecology and Population Health and at the Center for Biomedical Ethics at the New York University School of Medicine. Her research focuses on patient-physician communication, health disparities, and reproductive health and cancer.

Duncan Rose, GradDipPsych, MCLinPsych, is a registered and practicing clinical psychologist. He was previously a research officer in the Translational Health Research Institute at Western Sydney University, Australia, where he was involved in research examining gay and bisexual men's experience of prostate cancer.

Michael W. Ross, PhD, MD, MPH, MHPed, MSt, is a professor and the Jocelyn Elders Chair in Sexual Health Education in the Department of Family Medicine and Community Health at the University of Minnesota Medical School, Minneapolis. Dr. Ross is a prodigious researcher, having published over 500 peer-reviewed publications, mainly on LGBT health.

B. R. Simon Rosser, PhD, MPH, is a professor and clinical-research sexologist specializing in gay men's health in the Division of Epidemiology and Community Health at the University of Minnesota School of Public Health, Minneapolis. He pioneered the study of sexual function and dysfunction in gay and bisexual men (GBM); most recently, he led Restore, one of the first NIH-funded studies of prostate cancer in GBM.

Matthew B. Schabath, PhD, is an associate member in the Department of Cancer Epidemiology at Moffitt Cancer Center and associate professor in the Department of Oncologic Sciences in the Morsani College of Medicine, Tampa. He specializes in cancer epidemiology research, including health disparities among sexual and gender minorities and knowledge and attitudes of healthcare providers toward LGBTQ populations.

James Smith, PhD, is an associate professor and Equity Fellow with the Office of Pro Vice Chancellor—Indigenous Leadership at Charles Darwin University, Australia; he is also co-lead of the Indigenous Leadership Research and Evaluation Network. He has worked in men's health policy, practice, and research contexts in Australia for more than 15 years, with notable contributions in areas relating to men's health promotion, men's health policy development, and men's help-seeking practices and healthcare use.

Kristine M. Talley, PhD, RN, is an associate professor and codirector of the Center for Aging Science and Care Innovation at the University of Minnesota School of Nursing, Minneapolis. She is a certified gerontological nurse practitioner. A strong focus of her research is on rehabilitation for urinary incontinence, including that experienced after prostate cancer treatment.

M. Beatriz Torres, PhD, MPH CHP, is an associate professor of communication studies at Gustavus Adolphus College, in St. Peter, Minnesota. She specializes in health communication and health disparities. She was involved as a qualitative researcher in the data analysis of the Restore study (Aim 1).

Jane M. Ussher, PhD, CPsychol, is a professor of psychology in the Translational Health Research Institute at Western Sydney University, Australia. Her research focuses on examining subjectivity in relation to the reproductive body and sexuality, and the gendered experience of cancer and cancer care. As a trained clinical psychologist, she has also made a contribution to the integration of research and clinical practice in gendered health, and she has developed psycho-educational interventions in the field of cancer care, addressing sexual changes after cancer, fertility concerns, and the needs of cancer carers.

Andrea Waling, PhD, is a research officer at the Australian Research Centre in Sex, Health, and Society at La Trobe University, Melbourne. She specializes in the study of masculinity, bodies, men's health, and sexuality.

Richard Wassersug, PhD, is a prostate cancer patient and a research scientist, based in Vancouver, British Columbia, who spent most of his career as a professor of anatomy and neurobiology at Dalhousie University, Halifax, Nova Scotia. He is the lead author of the 2014 book *Androgen Deprivation Therapy: An Essential Guide for Prostate Cancer Patients and Their Loved Ones*.

William “Bill” West, PhD, is an instructor in the Department of Writing Studies, University of Minnesota College of Liberal Arts, Minneapolis. He specializes in health communication, including technical and professional communication, online pedagogy, the rhetoric of medicine, and communication in the patient-physician dyad.

Erik Wibowo, PhD, completed his doctoral studies at Dalhousie University and a post-doctoral fellowship at the Vancouver Prostate Centre. He is now working at the British Columbia Cancer Agency on a project, led by Dr. Tsz Kin (Bernard) Lee, to develop a questionnaire that can be used for assessing sexual function of men who have sex with men with prostate cancer.

Daniela Wittmann, PhD, LMSW, is an assistant professor of urology and a certified sex therapist at the University of Michigan Medical School. Her clinical work and research focus on couples’ sexual recovery after prostate cancer treatment. With funding from the Movember Foundation, she is leading in the United States a multisite trial of a web-based intervention for men and couples recovering sexual intimacy after prostate cancer treatment.
